MINUTES FOR 10/8/12 – Fred Nugent made the **motion** to approve the Minutes from 10/8, seconded by Pete Socks. The motion was carried with 5 years.

TOWNSHIP TRACTOR/MOWER QUOTES – Fred Nugent made the **motion** to send a Letter of Intent to Purchase to Messick's for the purchase of the Township tractor and mower, seconded by Pete Socks. The motion was carried with 4 years. Barry Cockley voted nay.

Bob Foltz made a **motion** to make a donation to Adams County Transit Authority (ACTA) for \$250, motion seconded by Pete Socks and carried with 5 years.
