

**BERWICK TOWNSHIP, ADAMS COUNTY
BOARD OF SUPERVISORS
REGULAR MEETING
MARCH 12, 2012**

CALL TO ORDER

The March 12, 2012 regular meeting of the Berwick Township Board of Supervisors, Adams County, was held in the Berwick Township Municipal Building, 85 Municipal Road, Hanover, PA. Chairman Robert Foltz called the meeting to order at 6:00 pm. Present were Supervisors Fred Nugent, Earle Black, Pete Socks, and Barry Cockley. Solicitor Tim Shultis and Township Secretary Karen Eakin were present. Bob Foltz asked all to stand for the Pledge of Allegiance to the Flag.

CITIZEN COMMENTS

FIRE TAX – Fred Nugent and Solicitor, Tim Shultis, explained that this is not a new tax and that the tax has not been increased from the previous year. The tax bill's new format shows the amount that goes to the fire department. The bill shows that out of the .123 mills, the Township general millage rate is .103 and United Hook and Ladder receives .02 mills. The funds are in lieu of a contribution to provide fire service for Berwick Township residents as required by Second Class Township Code.

EAGLE VIEW – Residents met with an attorney to draft a letter to the Attorney General addressing issues in the community. Broad Wing Drive is closed down to one lane and is in poor shape. Emergency vehicles cannot get through without driving on lawns. Bob Foltz made the **motion** to have the Solicitor send a letter to Don Irwin addressing the public safety issues on Broad Wing Drive, seconded by Barry Cockley. Motion carried with 4 yeas, 1 nay.
