ARTICLES OF INCORPORATION

TO THE SECRETARY OF THE COMMONWEALTH OF PENNSYLVANIA:

In compliance with the requirements of the Act of May 2, 1945, P. L. 283, known as the "Municipality Authorities Act of 1945", as amended and supplemented, and pursuant to an ordinance adopted by the municipal authorities of the Township of Berwick, Adams County, Pennsylvania, expressing the intention and desire of the municipal authorities of said municipality to organize an Authority under said Act, the said municipality hereby does certify:

1. The name of the Authority is the "Berwick Township Municipal Authority".
2. The said Authority is formed under the provisions of said Municipality Authorities Act of 1945.
3. No other Authority has been organized under the said Municipality Authorities Act of 1945, or under the Act of June 28, 1935, P.L. 463, as amended, and is in existence in or for the incorporating municipality.

4. The name of the incorporating municipality is:  
The Township of Berwick, Adams County, Pennsylvania.

5. The purposes of the Authority are to exercise any and all of the powers conferred by the said Act set forth in paragraph 3 hereof.
